

- Tenure appointment shall be subject to work and conduct of the Junior Resident/House Officer in the College/Hospital/Dispensary remaining satisfactory during his/her tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other activities which affect the hospital services/patient care, the tenure appointment of doctors shall be terminated without any notice.
- The Doctor shall be whole timer and shall not engage him /herself in private practice
 . In the event of those doctors found resorting to private practice their tenure
 appointment will be terminated without any notice and disciplinary action will be
 taken against them.
- 3. The Doctor shall be required to stay in the College / Hospital Premises if residential accommodation is available.
